SUBJECT: TRANSMITTAL OF INTEGRATED CHEMICAL EFFECTS TEST  
PROJECT: TEST #3 DATA REPORT AND APPENDICES

The attached subject Integrated Chemical Effects Test (ICET) test #3 data report is provided to support regulatory activities associated with GL2004-02. This data report provides the experimental results associated with ICET test #3. Results include a description of the test observations and process control parameters. The report also describes the results of post-test analysis on the sample coupons, fiberglass insulation samples, water chemistry, and precipitated solids. The attached appendices contain a more comprehensive set of the analyses conducted on these products.

Similar data reports will be provided for subsequent ICET tests 4 and 5. All test information will also be summarized in a NUREG/CR summary report that will be prepared once the individual test data reports have been provided. It is intended that the attached report and appendices be placed on the GSI-191 website and used to inform the public about current findings related to the ICET project.
