


The purpose of this modification is to: 1) Delete Item No. 10, of the Scope of Work under Modification No. 6, Attachment No. 1, Statement of Work entitled, "Statement of Work for Quadripartite Meeting Support," which requires the contractor to provide recreational tours for the participant's spouse and/or dependents, and 2) Extend the period of performance of the contract from October 31, 2006 through December 31, 2006, at no extra cost to the Government. Accordingly, the contract is hereby modified:

1) Item No. 10, under Scope of Work of the statement of work described in Attachment No. 1 to Modification No. 6, is deleted in its entirety.

2) Section B.5, DURATION OF CONTRACT PERIOD, as modified in Modification No. 6, is deleted and substituted with the following in lieu thereof:

"This contract shall commence on October 1, 2003 and will expired on December 31, 2006.

NOTE: The contractor is advised that the extension of the contract period beyond September 30, 2005 is only intended to provide for contractor logistical support for the Quadripartite Meeting and not the professional engineering and scientific support work provided for under the original statement of work of the contract."

This modification obligates no funds.

All other terms and conditions of the subject contract remain unchanged.
