

The purpose of this modification is to: (1) provide for an administrative change which incorporates the following Federal Acquisition Regulation Clause: FAR Clause 52.217-9, "Option to Extend the Term of the Contract," that was inadvertently omitted from the basic award document; (2) exercise option year 3 for the period January 1, 2006 through December 31, 2006, in accordance with FAR Clause 52.217-9; (3) incrementally fund this contract in the amount of \$25,000; (4) and revise FAR Clause 52.232-19 "Availability of Funds for the Next Fiscal Year. Accordingly, the following changes are hereby made:

1. Incorporate the following FAR Clause:

52.217- 9 OPTION TO EXTEND THE TERM OF THE CONTRACT

- a. The Government may extend the term of this contract by written notice to the Contractor within 30 days; provided that the Government gives the Contractor a preliminary written notice of its intent to extend at least 60 days before the contract expires. The preliminary notice does not commit the Government to an extension.
 - b. If the Government exercises this option, the extended contract shall be considered to include this option clause.
 - c. The total duration of this contract, including the exercise of any options under this clause, shall not exceed 4 years.
2. The annual rate for the "Energy Daily" subscription is \$25,000.00. Therefore, the total annual subscription rate of \$25,000 for the period January 1, 2006 through December 31, 2006 has now been obligated.

3. **52.232-19 AVAILABILITY OF FUNDS FOR THE NEXT FISCAL YEAR**

Funds are not presently available for performance under this contract beyond December 31, 2006. The Government's obligation for performance of this contract beyond that date is contingent upon the availability of appropriated funds from which payment for contract purposes can be made. No legal liability on the part of the Government for any payment may arise for performance under this contract beyond December 31, 2006, until funds are made available to the Contracting Officer for performance and until the Contractor receives notice of availability, to be confirmed in writing by the Contracting Officer.

A summary of obligations under this delivery order, from date of the award through this modification, is given below:

This modification obligates FY 05 funds in the amount of \$25,000.00.

All other terms and conditions, including the ceiling amount of \$100,000.00 remain unchanged.
