2. <u>Physical Description</u>

Thirty four (34) ANF-250 shipping containers of which thirty four (34) contain enriched UO_2 and none (0) are empty. The shipment contains 2,092 kgU and 48 Kg²³⁵U at an average enrichment of approximately 2.29 wt% U²³⁵. The ANF-250's are loaded in two sea containers.

3. Transport Route

The shipment will depart from Seattle, WA via the vessel "Hanjin Oslo" going to Busan, Korea. Upon arrival at Korea, KEPCO Nuclear Fuel Company, or its agent, will take physical custody of the shipment as arranged prior to shipment.

4. <u>Schedule</u>

The shipment is scheduled to depart Richland on September 15, 2005 and to depart Seattle, WA on September 18, 2005 and is expected to arrive at Busan on September 28, 2005.

5. <u>Assurance</u>

The shipment will be protected during transport in accordance with IAEA Information Circular 225, "Physical Protection of Nuclear Materials".
