
This letter is to follow-up my telephone call of the last week of September 2005.

College Heights Imaging has been closed for patient care since mid July 2005. At the end of September, our radioactive sources were sent to North American Scientific for proper disposal. Confirmation notice of receipt is enclosed. Following packaging of the sources, appropriate surveys of the Nuclear Medicine Division of College Heights Imaging was performed by our technologist. No radioactivity was identified.

As of October 1, 2005, there is no radioactivity within College Heights Imaging and appropriate surveys have been performed. I request that the licenses for the radioactive material be terminated.

Dr. Levin,

I am writing to confirm the closure of the Nuclear Medicine Laboratory at College Heights Imaging on September 23, 2005. As of this date, all radioactive sources were shipped to North American Scientific for disposal. Final Area Surveys and Wipe Tests were also completed on the entire Nuclear Medicine Department during my visit. Both the Area Surveys and Wipe Test results were found to be at background levels which were 0.03mR/hr and 1097dpm respectively. Please note that the last patient study was completed in the department on July 13, 2005 and all radioactive waste from this study was returned to the GE Healthcare Radiopharmacy in Wilkes-Barre, PA on July 14, 2005.

In closing, I would like to express my gratitude for the opportunity to be a part of your quality team of Healthcare Professionals who were committed to patient care. Your facility, I am sure, will be deeply missed by your loyal patient base.
