Mr. Andrew A. Greif has been appointed Temporary RSO for NRC Broadscope By-product Material License # 42-09388-01. The Johnson Space Center (JSC) Radiation Safety Committee approved Mr. Andrew Greif as a temporary RSO in accordance with 10 CFR 35, Subpart B, paragraph 35.24(c). In this capacity, Mr. Greif will act as the license RSO for up to 60 days a year during the absence of Mr. Dennis Waggett, the named NRC license RSO.

In accordance with 10 CFR 35, Subpart B, paragraph 35.24(g) and JPR 1860.2A, *JSC Radiological Health Manual*, the JSC Radiation Safety Committee has delegated to the temporary RSO sufficient authority, duties, and responsibility to identify radiation safety problems; initiate, recommend, or provide corrective actions; stop unsafe operations; and to verify implementation of corrective actions. Mr. Greif's specific RSO duties and responsibilities are outlined in paragraph 2.3 of JPR 1860.2A. The authority of the temporary RSO is the same as the NRC license RSO during his absence.
