Dear Mr. Cox:

On behalf of the Organization of Agreement States (OAS) Executive Board, I am pleased to advise you that you have been appointed to serve as the OAS representative on the NRC/Agreement States Task Force on the Energy Policy Act and Alternative Approach to Increased Control of Sources for the development of the technical basis for regulations related to the revised definition of by-product material in the Energy Policy Act of 2005 (EnPA), and the development of policies, procedures or other products related to the implementation of the Alternative Approach to Increased Control of Sources, effective immediately. This Task Force will work interactively with many different NRC Offices, as well as the representative from the Conference of Radiation Control Program Directors, Ms. Martha Diblee, and the Steering Committee overseeing the work of this Task Force.


