

The purpose of this modification is to decrease the amount obligated with respect to this contract by \$18,974.79 from \$458,000.00 to \$439,025.21, and revise Subsection G.2, entitled, "Indirect Cost Rates," to incorporate the final negotiated indirect rates for this contract in accordance with DHHS letter dated May 09, 2003. Accordingly, the contract is hereby modified as follows:

1. Under Subsection B.4, Consideration and Obligation—Cost Plus Fixed Fee, paragraph c is hereby deleted in its entirety and substituted in lieu thereof the following:

"c. The amount presently obligated by the government with respect to this contract is \$439,025.21."

2. Under Subsection G.2, entitled, "Indirect Cost Rates," is hereby deleted in its entirety and the following is substituted in lieu thereof:

"G.2. INDIRECT COSTS RATES
