Dear Mr. Iseman:

On July 12, 2005, Willie Lee of this office conducted a safety inspection at the above address of activities authorized by the above listed NRC license. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selected examination of representative records. The enclosed inspection report documents the findings of the inspection, which were discussed separately with you, Peter Leider, M.D. and George Sherouse, Ph.D. of your staff by telephone at the conclusion of the inspection on September 28, 2005. The report identifies that on July 12, 2005, you did not secure or maintain constant surveillance over a High Dose Rate Remote Afterloader containing licensed material.

You will be advised by separate correspondence of the results of our enforcement deliberations.
