This letter provides additional information regarding the application by Entergy Nuclear Vermont Yankee, LLC and Entergy Nuclear Operations, Inc. (Entergy) for a license amendment (Reference 1) to increase the maximum authorized power level of the Vermont Yankee Nuclear Power Station (VYNPS) from 1593 megawatts thermal (MWt) to 1912 MWt.

Reference 2 provided the draft Safety Evaluation (SE) prepared by the NRC staff in support of the proposed VYNPS license amendment for an extended power uprate. Entergy has conducted a review of the draft SE for the purpose of identifying proprietary information under 10 CFR 2.390. The SE contains proprietary information which is the property of General Electric Company. Corrections to the proprietary markings are designated in Attachment 1 to this letter by double underline within double square brackets. Entergy understands that the proprietary information was previously docketed with associated affidavits attesting to its proprietary nature, thus no additional affidavit is being provided.

There are no new regulatory commitments contained in this submittal.

This supplement to the license amendment request provides corrections to the marking of proprietary text and does not change the scope or conclusions in the original application, nor does it change Entergy's determination of no significant hazards consideration.
