Attached is a letter to Entergy dated 11/2/05 which transmitted Vermont Yankee EPU draft safety evaluation Revision 1 (public and non-public versions). The letter explains the differences between Revision 0 and Revision 1. I've also attached the publicly available version of the draft SE (Enclosure 1 to the letter). A hard copy of the letter and draft SE are being mailed to you separately. I will call you later this morning to confirm you received the electronic copy.

With regard to your concerns about the ACRS meeting being held during the day, as noted in the Federal Register notice for the meeting, the public may also provide written comments (e.g., if they are not able to attend in person).

During the 3/31/04 public meeting in Vernon, Bill Ruland said the NRC would be back to hold another meeting when we were further along in the review process. During the 12/16/04 VSNAP meeting in Brattleboro, Wayne Lanning said there will be a future meeting to discuss the power uprate review. My personal opinion is that this meeting is consistent with those statements and provides the public an opportunity to provide specific comments regarding the review given that the draft SE is now publicly available.
