We have reviewed the Maine commitment to implement increased controls for certain licensees that possess certain radioactive materials in quantities of concern, received by our office on November 8, 2005. This commitment noted that Maine will use a license condition identical to that provided by the Organization of Agreement States, Inc. (OAS) on September 6, 2005. The OAS suggested license condition was reviewed by comparison to the equivalent NRC requirements that were transmitted from this office on September 2, 2005. We discussed our review of the license condition with Mr. Shawn Seeley on November 8, 2005.

We have determined that the proposed Maine license condition, if issued without significant change, would meet the compatibility category 'B' designation in NRC Order EA-05-090.

We appreciate receiving the final license condition issued to effected Maine licensees.
