14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to extend the period of performance through August 31, 2005, at the current contract ceiling since there is enough ceiling remaining to cover the cost of this modification. The cost and fee are adjusted to include the fixed fee for this modification. The total estimated cost for this one month extension is \$73,373.32, of this amount \$69,220.11 represents the estimated reimbursable costs, and \$4,153.21 represents the fixed fee. Incremental funding in the amount of \$55,000.00 is being obligated at this time. Accordingly, the contract is modified as follows:

1. Section B.4, Consideration and Obligation is deleted entirely and replaced with the following:  
 (a) The total estimated cost to the Government for full performance of this contract is \$6,240,770.41, of which \$5,863,549.73 represents the reimbursable costs and \$377,220.68 represents the fixed fee.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
