Re: Board Conference with the Parties and the NRC on June 28, 2004

Date: June 11, 2004

The Public Service Board ("Board") will preside over a conference among the parties and representatives of the Nuclear Regulatory Commission ("NRC") on June 28, 2004, from 9:00 a.m. to noon, at the Public Service Board Hearing Room, Third Floor, Chittenden Bank Building, 112 State Street, Montpelier, Vermont. The purpose of the conference is to allow the NRC representatives to describe the regulatory process for reviewing the proposed power uprate of the Vermont Yankee Nuclear Power Station ("Vermont Yankee") and the new engineering inspection that the NRC plans to conduct at Vermont Yankee. The NRC has described these subjects in the attached letter to the Board dated May 4, 2004.

The Board has determined that the conference will be conducted in a manner similar to oral argument, with the parties and participants addressing the Board directly. The order of presentation at the conference will be as follows. First, the NRC representatives will describe the NRC's regulatory review process for the power uprate review and the planned engineering inspection for Vermont Yankee. Second, the parties to this Docket will be allowed to comment, to the Board, upon the NRC presentation. Third, the NRC representatives will be given the opportunity to respond, to the Board, in regard to the parties' comments. As in an oral argument, the Board may ask questions of the NRC and the parties during the course of, and at the completion of, their presentations. The NRC and the parties will not have an opportunity to ask questions of one another.

The conference is intended solely to provide information to the Board and the parties, and is not expected to be part of the evidentiary record in this Docket. Participants will neither be under oath nor subject to cross-examination. The conference will be recorded by a court reporter.
