Dave,

The submittal, Entergy letter BVY 04-058, dated 7/2/04, is not in ADAMS yet. I checked with Entergy and they said the letter was sent via regular mail to the Document Control Desk (DCC) on 7/6. I gave one of my copies (which Entergy sent via overnight mail) to the DCC this morning so they could add it to ADAMS in case the original got lost in the mail.

The letter contains proprietary information, but the non-proprietary portion will be publically available. The DCC said that it could be added to ADAMS in the next day or two. I asked that they make the document "immediate release" since it's been so long since it was submitted. The letter (EPU supplement 8) provides RAI responses, including many related to the steam dryer.
