NOTIFICATION OF SIGNIFICANT ENFORCEMENT ACTION

Licensee: Williams Industrial Services Group, LLC EA-01-082 and EA-04-172

Subject: CONFIRMATORY ORDER EFFECTIVE IMMEDIATELY

This is to inform the Commission that a Confirmatory Order (Effective Immediately) will be issued on or about November 15, 2005, to Williams Industrial Services Group, LLC (Williams). This action is based on commitments made to the U.S. Nuclear Regulatory Commission (NRC) by Williams as part of their settlement agreement for an apparent violation of 10 CFR 50.7, "Employee protection," and of 10 CFR 50.5(a)(2), "Deliberate misconduct," issued by the NRC on February 24, 2005. Reference EN-05-004. The settlement agreement was reached during an alternative dispute resolution (ADR) session on July 26, 2005.

In a letter dated March 25, 2005, Williams disputed the violations cited against the company and provided actions it had taken to avoid future violations. As part of the settlement agreement with the NRC, Williams agreed to take a number of additional corrective actions including: comparing its SCWE program with industry SCWE "best practices" to ensure the Williams Group program incorporates industry trends and developments, conducting periodic audits of their SCWE program to ensure its effectiveness; and modifying its existing "Ethics Policy" to include an explicit reference to the necessity for complete and candid communications with government agencies.

In view of the settlement agreement, and based upon the corrective actions that Williams has taken to date, the NRC agreed to withdraw the 10 CFR 50.5 violation cited against Williams Power Corporation on February 24, 2005. The 10 CFR 50.7 violation, originally issued as Severity level III, is being re-characterized as a violation without severity level specified.
