Subject: Three Mile Island Nuclear Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan, Revision 3

In accordance with 10 CFR 50.54, "Conditions of licenses," paragraph (p)(2), Exelon Generation Company, LLC (EGC) and AmerGen Energy Company, LLC (AmerGen) are submitting Revision 3 to the Three Mile Island Nuclear Station (TMI) Security Plan. The changes to the TMI Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan were implemented on September 9, 2005. In accordance with 10 CFR 50.54(p)(2), EGC is submitting this change within 60 days of implementation (i.e., by November 8, 2005).

The Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan have been revised to increase the minimum number of security responders by defining additional armed responders that the site maintains in order to implement the protective strategy. This increase resulted in changes to generic definitions, as well as other clarifications to the Security and Safeguards Contingency Plans.

EGC and AmerGen have concluded that the changes do not decrease the safeguards effectiveness of the TMI Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan.

Attachment 2 contains Safeguards Information. Therefore, EGC requests that this information be withheld from public disclosure in accordance with 10 CFR 2.390, "Public inspections, exemptions, requests for withholding," paragraph (a)(1)(i), and 10 CFR 73.21, "Requirements for the protection of safeguards information," paragraph (b)(1)(i).
