Subject: LaSalle County Station Security Plan, Training and Qualification Plan,
and Safeguards Contingency Plan, Revision 1

In accordance with 10 CFR 50.54, "Conditions of licenses," paragraph (p)(2), Exelon Generation Company, LLC (EGC) is submitting Revision 1 to the LaSalle County Station Security Plan. The changes to the LaSalle County Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan were implemented on September 12, 2005. In accordance with 10 CFR 50.54(p)(2), EGC is submitting this change within 60 days of implementation (i.e., November 11, 2005).

The Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan (SCP) have been revised to increase the minimum number of security responders by defining additional armed responders that the site maintains in order to implement the protective strategy. This increase resulted in changes to generic definitions, as well as other clarifications to the Security and Safeguards Contingency Plans.

The Physical Security Plan (PSP) and SCP have been revised to add clarifying information regarding the station's Early Warning System. The revision adds this clarification to Section 7, making it consistent with previously existing information contained in Section 10.3.


EGC has concluded that the changes do not decrease the safeguards effectiveness of the LaSalle County Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan.
