Re: Import/Export License Application for Multiple Countries Pursuant to 10 CFR 110

Dear Ms. Doane.

Precision Energy Services, Inc. (Precision), a subsidiary of Weatherford International Ltd.¹, wishes to apply for a multi-country export and import specific license in anticipation of the new requirements of 10 CFR Part 110, taking effect December 28, 2005, as specified in the July 1, 2005 Federal Register. This license is intended to include any radioactive material shipments listed in Appendix P to Part 110 that meet or exceed the import and export threshold limits, but typically Americium-241/Beryllium, in quantities exceeding per shipment. Any such shipments will fall within Category 2 of Appendix P. The requested time interval for this license is 10 years.

Precision (formerly Computalog USA, Inc.) provides energy services, including well logging, around the world. Precision is licensed to use and possess radioactive materials by the NRC under Materials License 42-26891-01 and Texas DSHS Radiation Control Radioactive Material License L00747, and various other Agreement State licenses. In addition, Precision has been issued several export licenses by NRC OIP in the recent past, including XB001304, XB001305, and XB001306 for radioactive material to be exported to India and XB13011 for export to Libya. In all cases the byproduct material was exported to foreign affiliates of Precision for their specific use in performing well logging services.

In applying for this new broad specific license, Precision asserts the following:

- 1) All exports and imports of byproduct material requiring a specific license under the new requirements of 10 CFR Part 110 will only be made to or from foreign affiliates which are legal entities of the parent company. No sales to 3rd party persons that are non-affiliates with Precision (Weatherford) will be made under this license application.
- 2) All imports and exports will not be inimical to the common defense and security of the United States.

¹ On September 1, 2005 Precision Energy Services, Inc. was acquired by Weatherford International Ltd. from Precision Drilling Corporation.

- 3) For all sealed sources containing Americium-241, quantities will not exceed per year to or from any one country, except for the United Kingdom or Canada which may be up to a calendar year.
- 4) Precision will only export or import radioactive material if the applicable US license(s) that authorize the possession of said radioactive material are current or in timely renewal status.
- 5) Precision is currently in contact with the DOE NNSA and working towards implementing improved physical security measures, as warranted, at our international locations.
- 6) When exporting from the USA, written permission will be obtained from the Competent Authority of the destination country as listed in the IAEA National Competent Authority List (NCAL) in the form of a license, permit, or "No Objection Certificate" (NOC) as applicable as specified in 10 CFR 10.32(h). For countries, where no such Competent Authority is listed, assistance from NRC OIP will be requested in advance.
- 7) Notifications of imports and exports will be made to NRC as specified by 10 CFR 110 and any specified license conditions.
- 8) The annual report as specified in 10 CFR 110.23(b) will be filed for all Amercium-241 exports.

It is essential that NRC OIP, the Executive Branch and the Commissioners understand that these exports of radioactive material are <u>not</u> sold to persons in the destination countries and are only used in conjunction with providing well logging services in these countries.

It essential that this license application include import, as well as export, privileges not otherwise granted by general license, as the expeditious and unimpeded return of disused sources to the USA is paramount to their security. This is in keeping with NRC's own adoption (RIN 3150-AD36) of the previous IAEA recommendations regarding disused sources as stated in the Federal Register, Vol. 60, No. 140, published Friday, July 21, 1995, Page 37556-37565:

"These types of transfers help to ensure that the materials are handled responsibly and not left in dispersed and perhaps unregulated locations around the world, and therefore they should not be subject to specific licensing if the radioactive material involved would not otherwise be subject to such licensing."

We are enclosing a check in the amount of \$12,800, that being the amount specified for in 10 CFR 170.31, Category 15. A., if Executive Branch and Commission review is required. A check (No. 577684) dated September 29, 2005 for this amount is enclosed if review beyond staff level is required. We respectfully request that the licensing action approval process not be delayed, if attempting to approve all the requested countries at one time would prevent issuance of the license before December 28, 2005. We request that approval of as many countries as is possible, especially Canada, Mexico, UK and European countries, be granted and a license issued before December 28, 2005, the deadline of when the new rules take affect. Other countries can be added as the review process completes for each country.

Attached is a list of countries in which Precision either has a current business presence or plans to have a business presence in the foreseeable future. An address has been provided for those countries
