Issue discussed: The allegor was originally concerned with ability to perform duties in accordance with the Transient Assessment Response Plan (TARP) team formation procedure. When contacted by OI chose not be interviewed and stated that would try to resolve concerns within the PSEG corrective action process. The NRC issued a conditional closeout letter to the allegor stating that the NRC will consider this allegation closed unless contacts us within 30 days of the date of the letter. did contact NRC in a November 20, 2002, letter and stated that wanted the NRC to keep the issue open.

In a telephone call and subsequent letter dated 12/20/02, the allegor wanted the NRC to pursue H&I claim and wanted to address the TARP issue.

DRP reviewed a 2/19/03 OI transcript (previously completed) and the final OI Report (OI Case no.1-2003-010) and did not identify any new technical issues. In their final report, OI did not substantiate that H&I took place.

In a 9/2/03 information package, the allegor indicated that PSEG is showing a continuing pattern of discrimination since he/she is taking medication that precludes him/her from being on the TARP team (Medical Department at PSEG is aware) but yet the individual received an unsatisfactory mid-year performance appraisal on 8/28/03.

OI completed their final review of the allegor's discrimination case ((1-2003-010S) and did not find sufficient evidence to prove that discrimination occurred.

Alleger initially declined to have the NRC pursue his discrimination issue. Thus, the original OI Case (1-2002-033) was closed since the alleger did not want to be interviewed and agreed no immediate safety issues existed when [redacted] was contacted by OI. In [redacted] 12/20 letter, no new technical information was provided to warrant raising OI's priority on this case. Later, he/she requested that OI pursue H&I. In their final report, OI did not substantiate that H&I took place.
