SUBJECT: STERIS ISOMEDIX SERVICES, REQUEST FOR ADDITIONAL INFORMATION CONCERNING APPLICATION FOR AMENDMENT TO LICENSE, CONTROL NO. 137611

Dear Mr. Young:

This is in reference to your letter dated August 30, 2005 requesting to amend Nuclear Regulatory Commission License No. 29-19769-03. In order to continue our review, we need the following additional information:

- 1. Provide a detailed description of the tasks to be performed during source transfer operations. Include a description of the surveys to be performed, dosimetry to be provided to personnel, and emergency procedures.
- 2. Provide an estimate of the collective dose, highest dose to an occupationally exposed individual, and highest dose to a member of the general public during the transfer operations. Provide the estimated dose in any one hour at the boundary to the unrestricted area and the estimated exposure rates during the key elements of the transfer operations.
- 3. Confirm that you will implement security procedures in accordance with all applicable Orders regarding radioactive material quantities of concern.
