Pursuant to 10 CFR 50.4, and sections C.1 and C.2 of NRC Order EA-03-097 (Enclosure of reference 1). Energy Northwest hereby reports compliance with the Additional Security Measures for access authorization at the ISFSI for Columbia Generating Station (Columbia). Energy Northwest has implemented the alternate means of compliance as specified in paragraph A.2 of Attachment 1 of the Order (EA-03-97). Energy Northwest is qualified to use the alternate means because its ISFSI is located at the same site as its power reactor and compensatory measures have been implemented as described in reference 2. Columbia's ISFSI license has been modified to require compliance with the Order as directed in reference 1.


