On August 18, 2004, the NRC issued an immediately effective order in the captioned matter.

By letter dated January 24, 2003 (CNRO-2003-00001), Entergy provided responses to *Order for Compensatory Measures Related to Access Authorization*, dated January 7, 2003 (RBC-49900). River Bend Station's independent spent fuel storage installation is located within the protected area. Therefore, the actions requested by the January 7, 2003, Order are complete and encompass the requested actions of the Order dated August 18, 2004 (RBC-50201). As a result, Entergy is in compliance with the applicable requirements of the August 18, 2004, Order and this submittal serves as notification of completion of the requested actions.
