Answer to Order for Implementation of Additional Security  
Measures Associated with Access Authorization for Trojan Nuclear Power Plant

On September 7, 2004, via letter VPN-050-2004, Portland General Electric Company (PGE) provided its response to the August 18, 2004 Nuclear Regulatory Commission (NRC) Order for Implementation of Additional Security Measures Associated with Access Authorization for Trojan Nuclear Power Plant at the Trojan Independent Spent Fuel Storage Installation (ISFSI). Subsequently, on October 4, 2004, PGE received a request for clarification of our response to item B.8 of the Order. The purpose of this letter is to provide the requested clarification.
