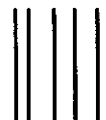
PRIVACY ACT STATEMENT

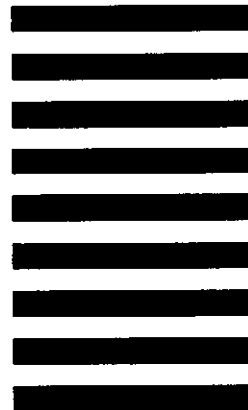

L. 102-589); 10 CFR Parts 15, 16, 170, and 171 (2000); Executive Order 9397 dated November 22, 1943; Debt Collection Improvement Act of 1996 (Public Law 104-134).
- 2. **PRINCIPLE PURPOSE(S):** To obtain taxpayer identification number / social security number / individual taxpayer identification number to enable the NRC to collect delinquent debts.
- 3. **ROUTINE USES:** Information from this form may be transmitted to: debt collection contractors and/or Federal agencies for collecting delinquent debts and/or collection action on such debts; any Federal, State or local agencies to conduct authorized computer matching programs and to credit reporting agencies; Treasury on past due nontax debts for the purpose of locating the debtor and/or effecting offset under Treasury Offset Program. Information may be publicly disseminated regarding the identity of delinquent nontax debtors and the existence of nontax debts under the provisions of the Debt Collection Improvement Act of 1996.
