ORDER

In a November 22, 2005 order, we directed the NRC Staff to file, by November 29, a third revised proposed draft protective order that spelled out all necessary provisions for the protection of safeguards information. Our order also expressly instructed that "[t]he Staff shall ensure that its safeguards expert review and approve the proposed protective order and expressly indicate that approval in its filing with the proposed protective order." Order (Nov. 22, 2005) at 2 (unpublished) (emphasis added).

Although the Staff timely filed its third revised proposed draft protective order, the Staff's filing did not indicate that a Staff safeguards security expert had reviewed and approved the proposed protective order. In a pleading filed by the close of agency business, Friday, December 2, 2005, the Staff shall comply with our November 29 directive. At the same time, the Staff shall inform us whether footnote 5 of its proposed protective order shall be deleted in

its entirety (as potentially contradictory of paragraph 5.a.) or deleted and replaced with a footnote merely referring to paragraph 5.a.

It is so ORDERED.
