ORDER (Scheduling Prehearing Conference)

On September 29, 2005, this Board granted a Motion filed by the NRC Staff in which it had requested that this proceeding be stayed until November 30, 2005. That Motion was the second request for a stay that had been filed by the NRC Staff and granted by this Board. That stay has now expired.

Although the stay it requested has expired, the NRC Staff has neither requested another stay nor has it provided to Mr. Siemaszko the information specified in 10 C.F.R. § 2.336(b). Instead, in a six line pleading filed on December 1, 2005, the NRC Staff stated that it "anticipates filing an additional stay request within the next week."

Accordingly, the Board directs that no later than 5:00 PM, EST December 7, 2005, the NRC Staff either produce the Section 2.336(b) materials to Mr. Siemaszko or, in the alternative, file any additional Motion. If an additional request for a stay is filed, responses will be considered if they are filed by 5:00 PM, EST, December 14, 2005.

The Board will hold a Prehearing Conference via telephone on December 15, 2005 at 12:30 PM, EST to hear oral argument on any pending motions and, if appropriate, set a schedule for the resolution of this proceeding.

Given that Mr. Siemaszko's request for a hearing was granted more than six months ago on May 19, 2005, given also that Section 2.336(b) directs that "the NRC staff shall, within thirty (30) days of the issuance of the order granting a request for hearing . . . and without further order or request from any party" provide discovery materials, and finally given that the stay granted in this proceeding has expired, the NRC Staff should be prepared to *immediately* provide the Section 2.336(b) materials in the event that an additional stay is not granted. <u>See</u> 10 C.F.R. § 2.336(e).

On or before 4:00 PM EST, on December 12, 2005, counsel for each of the parties shall contact Karen S. Valloch at (301) 415-7405 to obtain the telephone number and pass code for the conference call. To assure that the conference commences promptly at the scheduled time, all participants should access the conference a few minutes before 12:30 PM EST on December 15, 2005.
