Dear Dr. Onufer:

This is to confirm our telephone conversation on December 2, 2005 with Roy F. Heltzel, Jr. In which we discussed the information we need to continue review of your letter dated October 28, 2005. The items discussed are specified below.

- 1. The requested amendment is to remove the licensee's facility at 110 Wimbledon Square, Suite D, Chesapeake, Virginia. This location is the mailing address listed on the license. Please submit the new mailing address or confirm that 110 Wimbledon Square should remain.
- 2. NUREG-1757, Volume 1, Revision 1, "Decommissioning Process for Materials Licensees", Section 8 for Group 1 Decommissioning requires that the results from the most recent leak tests of all sealed sources including those no longer in licensee's possession be submitted. Please send in these leak test results.
- 3. The guidance in NUREG 1757, Volume 1, Revision 1, Section 8 requires NRC Form 314 or equivalent information. Thus please certify for the 110 Wimbledon Square, Suite D, Chesapeake, Virginia location that all activities authorized by the license have ceased and all materials procured and or possessed by the licensee under the license 45-25424-01 at that location have been disposed or transferred. Please give detail to when and where material was transferred. Please specify if transferred to another licensee and the associated license number. Please specify the date when all radioactive material was removed.
