NAC International, Inc. (NAC) submitted its response to the NRC staff's request for additional information (RAI) on September 29, 2005. The response included an entire revision to the Safety Analysis Report (SAR) and several proprietary documents. The proprietary documents were initially submitted in a electronic format that was not in accordance with the "Electronic Maintenance and Submission of Information" (E-rule) guidance for electronic summittals. Discussions were conducted with NAC regarding summittals that are both paper copy and electronic. NAC agreed to provide an additional proprietary summittal that would comply with the E-rule guidance.

On November 15, 2005, NAC made a proprietary summittal the included several documents and some associated CDs that addressed the staff's E-rule concerns. The November 15, 2005, summittal supplements the September 29, 2005 RAI response by providing additional paper copy and electronic files in accordance with the E-rule.
