ORDER

In a November 21, 2005 order, we indicated that we would subsequently issue a protective order covering the portions of the irradiator application of Pa'ina Hawaii, LLC (Applicant) redacted by the NRC Staff and set a schedule for the Petitioner, Concerned Citizens of Honolulu, to file its reply. The order also indicated that, because portions of the answers of the Applicant and the Staff dealing with the Petitioner's standing and environmental contentions did not appear to involve any information redacted from the irradiator application, we could move ahead on those matters and the Petitioner should file its reply dealing with the issues of its standing and environmental contentions by December 1, 2005. The Petitioner timely filed a reply.

Instead of responding to the answers of the Applicant and the Staff with respect to its standing and environmental contentions, however, the Petitioner's reply appears to address all its contentions, not just its environmental contentions. By doing so, it appears that the Petitioner has abandoned its claim that it needs the information redacted from the irradiator application in order to address adequately the answers of the Applicant and the Staff

addressing Petitioner's safety contentions.

Although it no longer appears necessary, we are today issuing a protective order and accompanying confidentiality and non-disclosure agreement in order to save time should the information redacted from the Applicant's irradiator application again become relevant in this proceeding. The Staff shall not provide to the Petitioner any protected information covered by the protective order without our further express order. In the event we have misapprehended the Petitioner's December 1, 2005 reply, the Petitioner may seek appropriate relief.

It is so ORDERED.
