We are in receipt of your letter dated October 25, 2005 requesting a waiver of the annual fee for License 24-32330-01 (Invoice AM3734-05). In your letter, you stated that you moved from Missouri to Kansas in September 2004, you obtained a radioactive materials license from the Kansas Department of Health and Environment, which became effective August 16, 2004, and you made a number of inquiries to NRC to obtain the formal license termination procedures but your attempts were unsuccessful. You also stated that you were directed to complete and fax Form NRC 314, "Certificate of Disposition of Materials," to NRC's Region III office, which you completed on September 30, 2005 and that your NRC license was officially terminated on November 3, 2005. In addition, you indicated you were unaware of the license termination deadlines to avoid being assessed an annual fee for fiscal year 2005.

The annual fee for fiscal year 2005 covered the period October 1, 2004 to September 30, 2005. Licensees who filed termination requests prior to October 1, 2004, and who permanently ceased operations by September 30, 2004, avoided assessment of the fiscal year 2005 annual fee. Additionally, 10 CFR 171.17(b) provides that licensees who file termination requests and permanently ceased operation during October 1, through March 31, of the fiscal year are assessed one-half of the annual fee. You did not timely file for the purpose of avoiding the annual fee or receiving a pro-rated assessment for the FY 2005 fee. However, based on your letter, I am granting you an extension of time to file for termination of NRC License 24-32330-01 to November 3, 2005, for the purpose of avoiding an fiscal year 2005 annual fee. As a result, your fiscal year 2005 invoice is cancelled.
