Thank you for the letter concerning the amendment to License #37-30669-01 concerning the addition of Dr. Randolph Pallas to the nuclear license. To clarify some of the issues of work experience under Section 10 CFR 35.290(C)(1)(ii) a. through g., please see the details below.

Subsection a., Ordering, Receiving and Unpacking of Radioactive Material Safety and Performing of Related Radiation Safety: Dr. Pallas has done 15 hours.

Subsection b., Performing Quality Control Procedures on Instruments Used to Determine the Activity of Dosages and Performing Checks on Proper Operation of Survey Meters: Dr. Pallas has done 20 hours.

Subsection c., Calculating, Measuring and Safely Preparing Patient and Human Research Subject Dosages: Dr. Pallas has performed 5 hours.

Subsection d., Using Administrative Controls to Prevent a Medical Event Involving the Use of Unsealed Byproduct Material: Dr. Pallas has done 35 hours.

Subsection e., Using Procedures to Safely Contain Spilled Radioactive Material and Using Proper Decontamination Procedures: Dr. Pallas performed 5 hours of time.

Subsection f., Administering Dosages of Radioactive Drugs to Patients and Human Research Subjects: Dr. Pallas has performed 5 hours.

Subsection g., Eluting Generator Systems Appropriate for Preparation of Radioactive Drugs for Imaging and Localization Studies, Measuring and Testing the for Radioactive Purity and Processing the Reagent Kits to Prepare Labeled Radioactive Drugs: Dr. Pallas performed 5 hours.

In addition to the above hours and the time previously listed for stress test supervision and nuclear reading, Dr. Pallas has also spent time with me going over ALARA and safety instrumentation in the
