On November 21, 2005, the U.S. Nuclear Regulatory Commission (NRC) staff and its contractor from Information Systems Laboratory (ISL) conducted a conference call (teleconference) with representatives from AmerGen Energy Company, LLC (AmerGen) and Erin Engineering and Research, Inc. (ERIN) to discuss the Oyster Creek Nuclear Generating Station (OCNGS) SAMA RAIs (ML053130387). The NRC staff formally sent the SAMA RAIs to NRC by letter dated November 9, 2005, regarding the environmental review of the application for license renewal for OCNGS. The teleconference was held to clarify these RAIs. Enclosure 1 contains a listing of teleconference participants.

AmerGen asked questions about several of these RAIs, and the NRC staff provided information to help clarify those questions. No staff decisions were made during the telephone conference. AmerGen plans to submit the responses to these RAIs by early January 2006.
