We have received your letter dated September 27, 2005, regarding the application from R.M.D. Operations, LLC, for a performance based multi-site license for uranium water treatment programs. This application has been assigned Technical Assignment Control Number LU0106. Please reference this number in any future correspondence associated with this request. As we discussed, the U.S. Nuclear Regulatory Commission (NRC) will respond with a final agency decision on whether to issue this license after the staff consults with the Commission.

Per our discussions, we will start the technical review of your license application in January 2006. However, even if our technical review results in a favorable decision, this will not guarantee that the license you have requested can be issued. Because of this uncertainty, we are asking you to document your decision to have NRC staff proceed, and we would like a decision within 14 days of the date of this letter.
