On December 13, 2005, at the request of Babcock & Wilcox Owners Group (B&WOG), the Nuclear Regulatory Commission (NRC) staff met with representatives of B&WOG to discuss reload licensing analysis related to Topical Report (TR) BAW-10179 "Safety Criteria and Methodology for Acceptable Cycle Reload Analyses."

The meeting began with B&WOG's presentation of details of the reload licensing analysis and its applicability to the planned revision to TR BAW-10179. The B&WOG explained that TR BAW-10179 is an extension of the licensing process permitted by Generic Letter 88-16 for removal of cycle-specific parameter limits from the technical specifications. TR BAW-10179 will be revised as Revision 7 to consolidate Revisions 1 through 6, incorporate 23 previous appendices into the report, update the methodology to incorporate the NRC-approved COPERNIC design code, summarize modified zero power physics testing program, expand discussion of emergency core cooling system analysis, and provide generic guidelines on the use of limited scope high burnup lead test assemblies.

The B&WOG planned to submit TR BAW-10179, Revision 7 for NRC staff review by December 31, 2005, and after the NRC approval of TR BAW-10179P-A, it will be referenced in the individual plants' core operating limit report.
