Dear Ms. Katz and Ms. Lampert:

On November 7, 2005, the Director of the Office of Nuclear Reactor Regulation issued a "Director's Decision Under 10 CFR 2.206" (DD-05-04), which addressed the concerns detailed in the August 10, 2004 petition of the Nuclear Security Coalition, as well as supplemental concerns submitted by Paul Gunter on behalf of the Nuclear Security Coalition. In a letter dated November 9, 2005, addressed to the Commission, Ms. Lampert requested that the Commission review Director's Decision DD-05-04. She also requested a public meeting between the NRC staff and the Nuclear Security Coalition in order to identify areas of agreement and disagreement between the Staff and the Coalition with respect to the determinations expressed in the Director's Decision.

NRC regulations provide that, within 25 days after the date of the Director's Decision, the Commission may on its own motion review that decision, in whole or in part, to determine if the director has abused his discretion. Review is at the discretion of the Commission. The Commission does not entertain a petition or other request for Commission review of a Director's Decision (see 10 CFR 2.206(c)). Therefore, in accordance with 10 CFR 2.206(c)(2) your request for a review of DD-05-04, as well as your request that the Commission require the NRC staff to meet with the Coalition, are denied.

The Commission has determined not to undertake a formal review of Director's Decision DD-05-04. Accordingly, the decision became final agency action on December 2, 2005.
