Dear Ms. Vietti-Cook:

The purpose of this letter is to endorse NEI's request (Ref. 1) for a 30-day extension on the comment period for the subject proposed rule.

The Westinghouse Owners Group (WOG) has expended substantial effort in support of this rule change and this proposed rule is of great importance to the WOG. The WOG is actively assembling comments from its membership. The occurrence of two major holidays during the comment period limits the time available to devote to the proposed rule. The extension would provide the WOG with the time necessary to assimilate the comments from its membership with regard to the potential safety and operational benefits associated with the proposed rule, to assemble a set of recommendations regarding new requirements in the rule, and coordinate the WOG comments with other industry comments and recommendations. We believe the requested extension is needed to ensure that the comments submitted by the WOG and industry are of high quality and value to the NRC staff.


