After careful consideration, these suggestions will not be adopted. Floor coordinators, floor monitors, stairwell monitors and monitors for the disabled are all voluntary positions which are very difficult to fill. Monitors are asked to check restrooms in life safety situations by first knocking on the door to see if they are occupied. If there is no answer, they are to open the door while giving a shout of the emergency. Once inside, they are to look under the stalls to verify that restrooms are vacant.
