The purpose of this modification is to (1) deobligate excess funds in the amount of \$169,879.01, thereby decreasing the total funds obligated under this contract from \$2,122,000.00 to \$1,952,120.99. Accordingly, the contract is modified as follows:

Under Section B.4 CONSIDERATION AND OBLIGATION--DELIVERY ORDERS (JUN 1988), the first sentence of paragraph (b) is deleted entirely and replaced with the following:

(b) The amount presently obligated with respect to this contract is \$1,952,120.99."

All other terms and conditions, including the contract ceiling amount of \$2,811,720.00, remain the same.

A summary of obligations for this contract, from the award date through the date of this action, is given below:
