Dear Joseph Nick:


This correspondence is intended to respond to the additional information requested in the above referenced letter.

1. It is my understanding that I met all required RSO training regulations until October of 2005 when a mistype error was submitted and written into the RSO training regulation, 10CFR 35.50, this regulation as finally published was not as originally drafted in the final rules which were voted on and approved by the Nuclear Regulatory Commission, I, then, respectively ask for an exemption/Variance to this error-regulation, if I cannot obtain an exemption then I submit Charles Rose to be my RSO. (I have enclosed a copy of an NRC license listing him as Radiation Safety Officer).
2. The dates and location of the 5a experience is Southside Community Hospital. 800 Oak Street, Farmville, VA from approximately 1993 to present and Physicians Imaging Center, P.O. Box 778, Red Bank, N.J. during the week of August 22-26, 2005.
3. Our facility will not be using a generator; we do not wish to be licensed to have a generator. We will be receiving unit-dose delivery from the pharmacy. I received, during my didactic laboratory training 8 hours of generator training. I ask for an exemption from this regulation.
