14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
 The purpose of this modification is to (1) exercise the twelve (12) month option period under the task order in accordance with Section C.7 under the subject contract; and (2) provide incremental funding of \$14,000 for the option period. Accordingly, the task order is hereby modified as follows:
 1. The second paragraph of the definitization letter is revised as follows:
 "The option period is hereby exercised by the Government in accordance with Section C.7 of the contract, for the period December 22, 2005 through December 21, 2006, at an estimated cost of \$60,231.16. Funds in the amount of \$14,000 are hereby obligated for performance of this task order for the option period." All other terms and conditions of the subject task order remain unchanged. A summary of obligations is provided as follows: FY 04 Obligations: \$8,000; FY 05 Obligations: \$51,000; FY 06 Obligations: \$14,000. Cumulative Obligations: \$73,000. This modification obligates FY 06 funds in the amount of \$14,000.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
