14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification is to (1) provide incremental funds in the amount of \$30,000, hereby increasing the obligated amount from \$18,458 to \$48,458 for the option period, and (2) change the technical monitor to Russell Gibbs at (301) 415-2988. Accordingly, the task order is hereby modified as follows:
1. Under paragraph two of the definitization letter, the second sentence is revised as follows:
"Funds in the amount of \$48,458 are hereby obligated for performance of the option period under the task order."
All other terms and conditions of the subject task order remain unchanged.
A summary of obligations is provided below:
FY 04 Obligations: \$21,300; FY 05 Obligations: \$51,333; and FY 06 Obligations: \$30,000.
Cumulative Obligations: \$102,633. This modification obligates FY 06 funds in the amount of \$30,000.
