The purpose of this modification is to exercise option period 1 (Year One) in accordance with FAR 52.217-9, Section C.13, and Section B.1.2 which hereby increases the firm fixed price by \$637,991 from \$218,120 to \$856,111. Accordingly, the contract is hereby modified as follows:

1. Section B.2, Consideration and Obligation—Firm Fixed Price (JUN 1988), is revised as follows:

"This clause applies to CLIN 001 and corresponding option year CLIN 001s, if exercised.

The firm fixed price of this contract for CLIN 001 for the base period is \$122,127, and \$497,362 for option period one (Year One). As stated under Section B.3(a) of this contract, the amount presently obligated is \$700,000, of this amount \$122,127 is obligated for CLIN 001 for the base period and \$497,362 for option period one."

2. Under Section B.3, Consideration and Obligation—Delivery Orders (JUN 1988), the first sentence of paragraphs (a) and (b) are revised as follows:

"(a) The total estimated amount of this contract for CLINs 2, 3, and 4 for the base period is \$95,993 and \$140,629 for option period one (Year One) for the products/services ordered, delivered, and accepted under this contract.

(b) The amount presently obligated with respect to this contract is \$700,000. A breakdown is as follows:

Base Period - CLIN 001 - \$122,127
Base Period - CLINs 2, 3, and 4 - \$77,873
Option Period One (Year One) - CLIN 001 - \$497,362
Option Period One (Year One) - CLINs 2, 3, and 4 - \$2,638"

3. Section B.4, Duration of Contract Period (MAR 1987) ALTERNATE 2 (MAR 1987), is revised as follows:

"The contract shall commence on October 1, 2005 and will expire on December 31, 2006. The term of this contract may be extended at the option of the Government for an additional 3 one-year options and one 9 month option."

All other terms and conditions of the subject contract remain unchanged.

A summary of obligations from the award date through the date of this modification are as follows:

FY 05 Obligations: \$200,000
FY 06 Obligations: \$500,000

Cumulative Obligations: \$700,000

This modification obligates FY 06 funds in the amount of \$500,000.
