The purpose of this modification is to (1) exercise Option Period One in accordance with Section C.6, FAR Clause 52-217-9, "Option to Extend the Term of the Contract (MAR 2000)", thereby extending the period of performance through February 16, 2007 (2) increase the contract ceiling amount by \$16,935.60 from \$22,035.60 to \$38,971.20 (3) incrementally fund this contract by \$20,000.00 from \$18,000.00 to \$38,000.00 and Accordingly the Contract is modified as follows:

(1) Refer to section B.5, "DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988)" first sentence is deleted in its entirety and replace with the following in lieu thereof:

"The ordering period for this contract shall commence on February 17, 2005 and will expire on February 16, 2007"

(2) Refer to section B.4, "CONSIDERATION AND OBLIGATION – DELIVERY ORDERS (JUNE 1988)" paragraph (a) first sentence is deleted in its entirety and replaced with the following in lieu thereof:

"(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$38,971.20"

(3) Refer to section B.4, "CONSIDERATION AND OBLIGATION – DELIVERY ORDERS (JUNE 1988)" paragraph (b) first sentence is deleted in its entirety and replaced with the following in lieu thereof:

"(b) The amount presently obligated with respect to this contract is \$38,000.00"

A summary of obligations from the date of award through the date of this modification is provided below:

This modification obligates FY05 funds in the amount of \$20,000.00.
