The purpose of this contract modification is to extend the period of performance in Option Period 4 for an additional three (3) months. Accordingly, the contract is modified as follows: The total firm fixed price of the contract is increased by \$79,042.59 from \$1,204,213.01 to \$1,283,255.60. Section B.4 is changed to read, "The firm fixed price of this contract is \$1,283,255.60." Section F.2 of this contract is changed to read, "The contract shall commence on June 18, 2001 and will expire on February 17, 2006."

All other terms and conditions remain unchanged.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
