

The purpose of this modification is to obligate FY'06 funds in the amount of \$10,000.00, thereby increasing the obligated amount of the subject contract from \$126,000.00 to \$136,000.00. Accordingly, the contract is modified as follows:

Under Subsection B.4 – CONSIDERATION AND OBLIGATION/CONTRACT CEILING, paragraph “b” is deleted in its entirety and the following is substituted in lieu thereof:

- “b. The amount presently obligated with respect to this contract is \$136,000.00. This obligated amount may be unilaterally increased from to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contact. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor’s sole risk.”

A summary of obligations for this contract from award date through the date of this action is given below:

This modification obligates FY'06 funds in the amount of \$10,000.00.

All other terms and conditions under this contract, including the ceiling amount of \$156,232.35 remain unchanged.
