The purpose of this modification is to provide incremental funding in the amount of \$107,776 hereby increasing the obligated amount from \$175,000 to \$282,776 and fully funding the contract. Accordingly, the contract is hereby modified as follows:

Under Section B.3, CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUNE 1988) ALTERNATE I (JUNE 1991) paragraphs (c) and (d) are deleted in their entirety and replaced with the following:

- “(c) The amount presently obligated by the Government with respect to this contract is \$282,776 of which the sum of \$261,913 represents the estimated reimbursable costs, and of which \$20,863 represents the fixed fee.
- (d) The obligated amount will cover performance through May 19, 2006.”

All other terms and conditions, including the ceiling amount of \$282,776, remain unchanged.

A summary of obligations, from the award date through the date of this action, are provided below:

Total FY 06 Obligations:	\$107,776
Cumulative Obligations:	\$275,776

This modification obligates FY 06 funds in the amount of \$107,776.
