The purpose of this modification is to exercise Option Year Number Three of the subject contract; provide funding in the amount of \$158,807.00 to cover performance starting December 1, 2005 through November 30, 2006; and extend the period of performance from November 30, 2005 to November 30, 2006.

Accordingly, the contract is modified as follows:

1. Option Period Three, is hereby exercised. As a result, the ceiling amount of the subject contract is hereby increased by \$158,807.00 from \$297,233.18 to \$456,040.18.
2. Under Contract Clause C.3, "DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MARCH 1987)" the first sentence is hereby deleted in its entirety and replaced with the following:

"The contract shall commence on December 1, 2003 and will expire on November 30, 2006."

3. Under Section B.1 "CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988)" first sentence in paragraph (a) and (b)" are revised to read as follows:

"(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$456,040.18.

(b) The amount presently obligated with respect to this contract is \$438,250.00."

All other terms and conditions remain unchanged.

This modification obligates FY 2006 funds in the amount of \$158,807.00.
