A. The purposes of this modification are to: (1) fully fund the task order; (2) increase the task order ceiling and provide funds for this increase, as a result of the travel expenses being higher than the original estimate; and (3) make an administrative change to the task order.

B. Task Order Page 2, Paragraph 3, the amount of incremental funds is corrected to read: \$39,162.82.

C. The total amount obligated is increased by \$3,803.95, from \$39,162.82 to \$42,966.77. The total task order ceiling amount is increased by \$734.55, from \$42,232.22 to \$42,966.77.

D. All other terms and conditions of the task order remain the same.
