The purpose of this modification is to 1) to make an administrative change by correcting B.4, Item 6 to read, "The total estimated fixed contract price (ceiling) for this contract including all options is \$260,959.00; 2) to exercise Option Year 1 and 3) prepare the funding for Option Year 1.

Accordingly, the contract is modified as follows:

1. The period of performance is from 12/01/2004 to 11/30/2006. There are three additional option years remaining under this contract.
2. "Option Year One, is hereby exercised. As a result, the ceiling amount of the subject contract is hereby increased by \$50,331.00 from \$50,000.00 to \$100,331.00.

As summary of obligations for this contract from the date of award through the date of this action is provided below:
